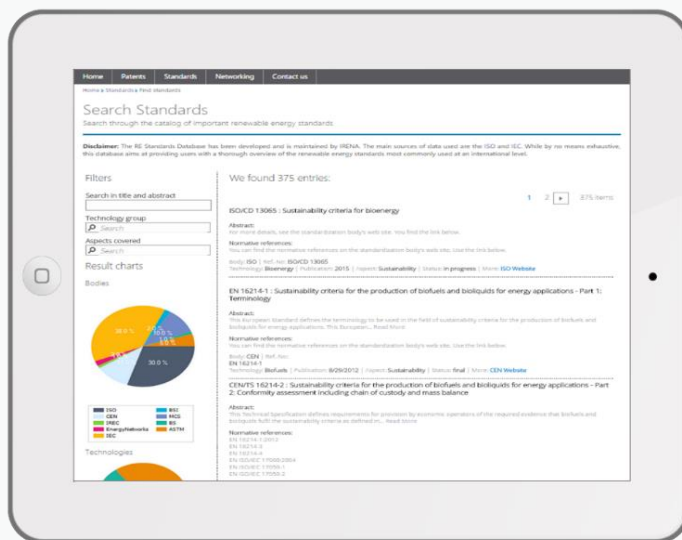
SUMMARY

The purpose of the information platform for RET patents and standards – INSPIRE - is to facilitate the access to such information by:

- Providing one entry point for information on RET patents and standards for the public interested in RE but non-experts in standards or patents
- Relating the information to practical applications
- Informing the users on what are and how to use patents and standards for the deployment of RET
- Facilitating a dialogue between the different stakeholders on these topics

OBJECTIVES OF THE EVENT

- Launch the first version of IRENA's platform on “International Standards and Patents in Renewable Energy - INSPIRE”. Present the features of the platform and the applications of this platform for policy-makers.
- Discuss with key partners, including the UNFCCC Technology Executive Committee (TEC), the International Electrotechnical Commission (IEC), the World Intellectual Property Organization (WIPO) and the European Patent Office (EPO), the practical uses of standards and patents information relevant to policy-makers and other RE stakeholders.
- Obtain feedback from participants on how IRENA and other partner organizations can continue to support national policy-making processes concerning RET innovation.
